

OBLIGATION TO PRESENT A NEGATIVE COVID-19 TEST

CANARY ISLANDS **SAFE DESTINATION**

To ensure a stay in the maximum **conditions of safety and quality**, and maintain the archipelago's low incident rate for the pandemic:

You must present a certificate to this establishment to show that you have tested negative for active COVID-19 infection.

1 The test must have been taken in the past **72 hours** and be **recognised by the healthcare authorities** of your country or the European Union.

2 The certificate is **compulsory for everyone over the age of six** who wishes to stay at any tourist accommodation in Canary Islands.

3 You may show a **digital or hard copy** of it.

4 It must contain the **date and time** the test was taken, the identity of the individual taking it, the **authorised centre** responsible for verification, and the **negative result**.

5 This certificate will not be required for **visitors who show proof** (in the form of their travel document) that they have been in Canary Islands for 15 days or for **Canary Islands residents who declare** that they have not left the archipelago in the 15 days prior to arriving at this establishment. Neither the residents or the visitors can have had **any symptoms of COVID-19** during that time.

LA ISLA Y EL MAR, HOTEL BOUTIQUE, WILL DENY ENTRY TO ANYONE WHO DOES NOT COMPLY WITH THE ABOVE CONDITION.

We remind you that you must do the PCR test or an antigen test **72 hours before** flying to Lanzarote and deliver your certificate, of the negative result, at the Reception upon arrival at the hotel. **In the event that it is not possible to do the test at your place of origin**, the hotel offers you the possibility of taking this **test at your destination***. Applicable to reservations in advance of 72 hours upon arrival at the hotel. See conditions.

IF YOU BOOK A 4-NIGHT STAY OR MORE WITH US THROUGH OUR WEBSITE, WE WILL COVER THE COST OF THE TEST. WE CARRY OUT THE TEST AT THE HOTEL AND YOU WILL RECEIVE YOUR RESULT IN 30 MINUTES*.

*** TEST DONE LOCALLY VALID UNTIL NOVEMBER 23rd., FROM THIS DATE, THE TEST MUST BE CARRIED OUT IN THE COUNTRY OF ORIGIN AND ONLY A PCR TEST WILL BE VALID.**
